Providing artisan products means always having access to the freshest ingredients, including the finest California EVOO. It also means a continued commitment to handcrafting each and every batch. This is the promise—and the taste—at the heart of Sutter Buttes Olive Oil Company.

Their Extra Virgin Olive Oils are of the highest quality available on the market. Fruit for these oils is grown within a 30 mile radius from the Sutter Buttes, a Sacramento Valley volcanic formation created 300 million years ago. This area is known for its abundance of fruit orchards which directly influences the flavor of oils.

Arbequina, their signature olive oil, is mild in its intensity with a distinct fruit fragrance. It continuously achieves acidity levels below 0.3% (0.8% minimum to be Extra Virgin). Fruit is mechanically harvested and processed as early as 1 hour after picking. State of the art modern machinery and prompt pressing guarantee that California Extra Virgin Olive Oils offered by Sutter Buttes Olive Oil Co. are of the highest quality as proven by many awards in the international arena.

Wholesale FAQ

- What is the Minimum Purchase?
 - \$250, a \$15 service fee will be added to all orders under \$250 and the shipping caps will not be applied.
- What will shipping cost?
 - We cap shipping at 20% of the merchandise total on wholesale orders that meet the minimum (\$250). We cap shipping at 10% of the merchandise total for wholesale orders that are \$1000 or more. For orders of \$5000 or more, we will ship for free.
- When will the order ship?
 - We have a 7-10 day processing time on all in-stock orders.
- Do I have to order full cases?
 - We can split cases, half and half, in the same category, but we must have full cases to ship.
- How does bulk pricing work?
 - We offer bulk oils and vinegars in 2.5 gallon jugs (shipped in cases of 2), 55 gallon drums and 275 totes. Bulk pricing by the gallon is shown on pages 3-4 of the price list. (Most flavors are \$112.50 per 2.5 gallon jug). There is a \$50 drum fee and a \$200 tote fee in addition to the price of the oil.
 - There is an additional 5% discount for 20+ gallons of a single sku.
- Do you offer Samples?
 - We have a wholesale sample pack for Oils, Vinegars, Tapenades, Mustards, Jams, Salts and Rubs. Customers can choose 10 of these items for \$20.00 PLUS shipping. The \$20 becomes a credit towards your first wholesale order. If customers would like to try items NOT included in the sample pack they can be purchased at single unit wholesale cost.
 - We have customer sampling units available with orders, for each full case of product – a sample unit can be purchased at 50% wholesale up to 3 samples per sku.
- Do you offer Private Label?
 - We offer In-House Private Labeling with a 20 case per order minimum. More details are available in our 2018 Private Label document.
 - We also offer the option for customers to create their own labels, and once we approve them, have them shipped here for application prior to shipping. This also has a 20 case per order minimum.
- Do you offer Payment Terms?
 - We offer payment terms through a 3rd party financier, Behalf. Additional information can be found in the Behalf Terms Letter.
